ORDINANCE 08-09-A

AN ORDINANCE AMENDING ORDINANCE 0-77-6A SEEKING TO ESTABLISH A FLAT RATE OF \$25 PER MONTH FOR SEWER SERVICE TO THOSE RESIDENTS NOT DOMICILED IN THE VILLAGE OF MAURICE; HOWEVER, DOMICILED WITHIN 300 FEET OF A SEWER COLLECTION SYSTEM.

BE IT ORDAINED by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, acting as the governing authority of said Village:

- A. Ordinance 0-77-6A be amended by amending Section 1 such that every owner, tenant or occupant of each lot or parcel of land in the Village and/or within 300 feet of a sewer collection system nearby the Village.
- B. In addition, Ordinance 0-77-6A shall be amended by altering Section 2 such that the Village is now allowed to charge a flat rate of \$25 per month for sewer service regardless if connected to the sewer system or not. The ordinance shall hereafter read as follows:

“1. That acting in the exercise of the police powers of the Village of Maurice, State of Louisiana (the “Village”) every owner, tenant or occupant of each lot or parcel of land in the Village and/or nearby the Village within 300 feet of a sewer collection system which abuts upon a street or public way containing a sewer line within 300 feet of such lot or parcel and upon which lot or parcel a building shall have been constructed for residential or industrial use is hereby required by the Village to connect said building with the sewer system and to cease to use any other method for the disposal of sewerage, sewerage waste and/or other polluting matter. All such connections shall be made in accordance with the rules and regulations to be adopted from time to time by the Mayor and Board of Aldermen of the Village which rules and regulations may provide for an inspection charge to ensure the proper making of such connection.

2. The following schedule of rates shall be placed in effect and neither said schedule nor any subsequent schedule shall be reduced at any time except in accordance with the provisions of the resolution authorizing the issuance of revenue bonds of the Village and unless such schedules as so reduced will in each year thereafter produce sufficient revenues to meet and fulfill all provisions of said bond resolution, viz:

Residential Rate Outside Maurice But Within 300 Feet of Sewer Collection System: \$25.00 per month

This Ordinance shall become effective upon adoption.
