

**TOWN OF MAURICE
ORDINANCE NO. 22-6A**

**AN ORDINANCE ADOPTING THE OPERATING BUDGET OF
REVENUES AND EXPENDITURES FOR THE FISCAL YEAR
BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023**

BE IT ORDAINED by the Board of Aldermen, of the Town of Maurice, Louisiana in general convened that:

SECTION 1. The attached detailed estimate of Revenues for Fiscal Year beginning July 1, 2022 and ending June 30, 2023, be and the same is hereby adopted to serve as an Operating Budget of Revenues for the Town of Maurice, Louisiana during the same periods.

SECTION II. The attached estimate of Expenditures by departments for the Fiscal Year beginning July 1, 2022 and ending June 30, 2023, be and the same is hereby adopted to serve as a budget of expenditures for the Town of Maurice, Louisiana during the same period.

SECTION III. The adoption of this Operating Budget of Expenditures be and the same is hereby declared to operate as an appropriation of the amount therein set forth within the terms of the budget classification.

SECTION IV. Amounts are available for expenditures only to the extent included within the 2022-2023 budget.

SECTION V. The Mayor of the Town of Maurice shall have the authority to make changes within various budget classifications as well as the transfer of funds between departments within 2% of the total budget without approval by the board. Anything in excess of 2% of the total budget would require approval by the board.

Said Ordinance having been introduced on May 31, 2022 and notice of public hearings having been published, said public hearings having been held, the title having been read and the Ordinance considered, a record vote was taken and the following results were had:
