ORDINANCE NO. 11-6B

AN ORDINANCE AMENDING ORDINANCE 08-01-C

BE IT ORDAINED by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, acting as the governing authority of said Village:

A. Subsection 2) of Ordinance 08-01-C be amended to read as follows:

“2) The rates for the 2010 and 2011 calendar years shall be assessed at seventy-five (75%) percent of the schedule. Further, the rates for the 2012 and all following calendar years shall be assessed at seventy-five (75%) percent of the schedule set forth in LSA R.S. 47:341-363, with a ten (10%) percent discount awarded if filed and paid prior to the last working day of January of the assigned calendar year.”

B. The following language be added to Ordinance 08-01-C:

“Further, beer and liquor permits will be issued contingent upon the payment of a Twenty-Five and No/100 (\$25.00) Dollar processing fee at the time of issuance. In addition, the issuance of the beer and liquor permit shall be contingent upon the possession of the appropriate occupational license that is valid by the end of the first quarter of that calendar year.

“Any individual operating a business which requires issuance of an occupational license who fails to secure a valid annual occupational license shall be assessed the following penalties:

- a. Interest at the rate of one and 25/100 (1.25%) percent per month of the tax due from the due date until the tax is paid;**
- b. A penalty of five (5%) percent of the tax due for each thirty (30) days, or fraction thereof from the due date until the return is filed, but limited to a total of twenty-five (25%) percent.”**

This Ordinance shall become effective upon adoption.

WHEREUPON, the above Amended Ordinance was read section by section, and was submitted to a vote, the vote thereon being as follows:
