## An Ordinance Establishing Certain Rules Applicable To The Maurice Park

\_\_\_\_

**BE AND IT IS HEREBY ORDAINED** by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, acting as governing authority of said Village that:

The Village of Maurice, Louisiana, does hereby establish that the following rules shall be applicable to the Maurice Park ("Park"):

- 1) No glass containers shall be permitted upon Park property;
- 2) No motorized vehicles shall be permitted upon any grassy area of the Park;
- 3) The Park shall open at sunrise and close at sunset, and no person shall be present in the Park except during those hours; and
- 4) No parent or guardian shall allow a child under his custody or control below the age of fourteen (14) to be present in the Park without adult supervision.

Any person found guilty of violating any provision of this ordinance shall be ordered to pay a fine of not more than FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS, or imprisoned for not more than sixty (60) days, or both.

THIS ORDINANCE shall become effective upon publication.
