## VILLAGE OF MAURICE ORDINANCE 11-5 AN ORDINANCE AMENDING SEWER USE ORDINANCE 80-3A, ORDINANCE 98-1A, ORDINANCE 77-6A, ORDINANCE 92-11A and ORDINANCE 08-09A BY AMENDING SECTION 1003 TO REVISE THE SEWER RATE FOR RESIDENTIAL CUSTOMERS

BE IT ORDAINED by the Mayor and Board of Aldermen of the Village of Maurice,

Louisiana, that Section 1003 of Ordinance No. 80-3A, Ordinance 98-1A, Ordinance 77-6A,

Ordinance 92-11A and Ordinance 08-09A are hereby amended to reflect the following:

"The monthly user fee for wastewater services shall be based on the volume of water consumed.

## **RESIDENTIAL, COMMERCIAL, INDUSTRIAL, NON-RESIDENTIAL PREMISES**

All residential, commercial, industrial and non-residential premises (all customers except for industrial customers) connected to the Village's sanitary wastewater system shall be charged the following rate:

*Monthly volumetric charge:* A flat rate of Six and No/100 (\$6.00) Dollars per two thousand (2,000) gallons or part thereof of water used; thereafter, a usage rate of Two and 36/100 (\$2.36) Dollars per one thousand (1,000) gallons or part thereof of water used thereafter."

#### INDUSTRIAL (INSIDE CORPORATE LIMITS)

All industrial customers as defined as customers discharging or using the waste water system for discharging large amounts of wastewater other than domestic sewerage waste who are located within the corporate limits of the Village and connected to the Village's sanitary wastewater system shall be charged the following rate:

*Monthly volumetric charge:* Three and 80/100 (\$3.80) Dollars per thousand (1,000) gallons or part thereof of water used or discharged through a separate meter.

All other references of sewer rates in the preceding ordinance shall remain in full force

and effect.

This Ordinance shall become effective upon adoption.

submitted to a vote, the vote thereon being as follows:
