AN ORDINANCE AMENDING SEWER USE ORDINANCES 98-10A, 08-09A, 0-77-6A, 6-8-77, 11-7, 15-9, AND 18-2A IN ORDER TO ADJUST THE SEWER USER FEES

BE IT ORDAINED by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, that Ordinances 98-10A, 08-09A, 0-77-6A, 6-8-77, 11-7, 15-9, AND 18-2A are hereby amended to reflect the following:

- 1. The monthly sewer user fees are hereby amended by this ordinance with the rates shown for each year to be implemented and charged to the customers served by the Village of Maurice's sewer system based on the following schedule:
 - a. The rates shown for 2018 shall be implemented with the April billing cycle (for March consumption).
 - b. The rates shown for 2019 and 2020 shall be implemented with the February billing cycle of each year (for January consumption).
