ORDINANCE 11-7

**AMENDING ORDINANCE NUMBERS 08-09-A and 0-77-6-A
Adopted on 9-17-08 and 6-8-77, Respectively**

**Amended Ordinance Establishing a Flat Rate
of \$31.25 Per Month for Sewer Service for Those
Residents Not Domiciled in the Village of Maurice and/or not connected to the
Village of Maurice Water System;
However Domiciled Within 300 Feet of a Sewer Collection System,
Along With Establishing a Short Service Rate of \$150 and a
Long Service Rate of \$500**

BE IT ORDAINED by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana,
acting as the governing authority of said Village that:

The Village of Maurice, Louisiana, does hereby amend Ordinance Numbers 08-09-A and 0-77-6-A as follows:

“A. Ordinance 08-09-A and 0-77-6-A shall be amended by altering Section 2 such that the Village is now allowed to charge a flat rate of Thirty One and 25/100 (\$31.25) Dollars per month for sewer service, regardless if connected to a sewer system or not.

B. Ordinance Numbers 08-09-A and 0-77-6-A shall be amended to add a flat rate of One Hundred Fifty and No/100 (\$150.00) Dollars for a short service boring operation to comply with said Ordinance and to establish a Five Hundred and No/100 (\$500.00) Dollar long service boring operation to comply with said Ordinance.”

WHEREUPON, the above Ordinance was read section by section, and was submitted to a vote, the vote thereon being as follows:
