

**VILLAGE OF MAURICE  
ORDINANCE 11-9C**

**AN ORDINANCE AMENDING WATER USE ORDINANCE No. 92-11B,  
ORDINANCE 94-10A, ORDINANCE 07-11A, AND ORDINANCE 09-04A  
IN ORDER TO ESTABLISH WATER RATES FOR  
MULTI-FAMILY HOUSING AND NURSING HOME/ASSISTED-LIVING FACILITIES  
WITHIN THE VILLAGE OF MAURICE**

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, that Ordinance No. 92-11B, Ordinance 94-10A, Ordinance 07-11A, and Ordinance 09-04A are hereby amended to reflect the following:

**The monthly user fee for water services shall be based on the volume of water consumed as measured at all water meters for the facility.**

**MULTI-FAMILY HOUSING FACILITIES (Inside Corporate Limits)**

All Multi-Family Housing Facilities, defined as a housing classification where multiple separate housing units for residential inhabitants are contained within one building or several buildings within one complex, connected to the Village's water system shall be charged the following rate:

*Monthly Flat Rate:* \$10 per number of apartment units in the complex

*Monthly Volumetric Charge:* A usage rate of Three and 00/100 (\$3.00) Dollars per one thousand (1,000) gallons or part thereof of water used.

**NURSING HOME/ASSISTED-LIVING FACILITY (Inside Corporate Limits)**

All Nursing Homes/Assisted-Living Facilities, defined as a facility providing housing for the elderly, disabled or persons with special needs, connected to the Village's water system shall be charged the following rate:

*Monthly Flat Rate:* \$15.00 for the first 2,000 gallons or part thereof

*Monthly Volumetric Charge:* A usage rate of Three and 25/100 (\$3.25) Dollars per one thousand (1,000) gallons or part thereof of water used after the first 2,000 gallons.

All other references of water rates in the preceding ordinances shall remain in full force and effect.

This Ordinance shall become effective upon adoption.
